

Dell Technologies President's Circle Program OFFICIAL PROGRAM RULES

YOU ACKNOWLEDGE THAT YOUR PARTICIPATION IN THE PROGRAM IS STRICTLY VOLUNTARY AND IS NOT REQUIRED BY DELL TECHNOLOGIES.

- 1. Eligibility: Dell Technologies President's Circle** (the "Program") is open to Dell Technologies Partner Program Distributors, Solutions Providers, OEM Partners, Systems Integrator Partners, Strategic Outsourcer Partners, Industries Partners, or Cloud Service Provider Partners, and VMware Partner Program Partners participating in the Dell Technologies¹ Partner Program or the VMware Partner Program ("Dell Technologies Partner" and "VMware Partner" as applicable and collectively "Partner") provided that Partner;
 - a. is in good standing in the applicable Program prior to the start of the Program Period and must not be subject to disciplinary actions (current), or found in breach of terms, or subject to other compliance concerns.
 - b. meets Dell Technologies fiscal year 2020 ("FY20")² Partner Tier or VMware Partner Program compliance requirements in both revenue and training.
 - c. maintains a current registration profile including yearly updates and prompt notification to Dell Technologies or VMware in writing of any change that may affect Partner's participation.

The following Dell Technologies President's Circle Official Program Rules ("Program Rules") apply to Partner's participation in the Program. *The Program Rules are supplemental and subject to 1.) for the Dell Technologies Partners Dell Technologies Partner Program Agreement, the Dell Technologies Partner Incentive Terms and Conditions, 2.) for VMware Partners the VMware Partner Program terms and conditions, and together with any attachments thereto (collectively this "Agreement")* Employees of Dell Technologies and VMware Inc. ("VMware"), and any of their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Program is subject to all applicable country, federal, state, provincial and local laws and regulations and is void where prohibited. The President's Circle Contest is not available in all countries, please check with your legal counsel or designated Ethics Officer with questions about your ability to participate in this program. Dell Technologies and VMware reserve the right to exclude any Partner or specific country at any time in its sole discretion.

- 2. Sponsor:** Dell Marketing, L.P. One Dell Way, Round Rock, TX 78682.
- 3. Agreement to Official Rules:** Participation in this Program constitutes Partner's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to this Program. Winning a Trip is contingent upon fulfilling all requirements set forth herein.
- 4. Timing:** The Program begins on August 22, 2019 at 12:00 a.m. ("CT") and ends on January 31, 2020 at 11:59 p.m. CT (the "Program Period").
- 5. Program Description:** One Partner representative (hereafter "Trip Recipient") at each selected Partner will receive a trip for Trip Recipient and one (1) Guest ("Guest") for a four (4) night stay Hilton Canopy Hotel in Reykjavik, Iceland³ for the President's Circle Summit at the (ARV US \$13,000.00 USD per person) ("Trip"), provided that Partner meets the Eligibility requirements in Section 1 and the following criteria.

- a. Dell Technologies Partners must meet or exceed the minimum revenue and growth thresholds in Table 1 below. Thresholds are calculated based on the weighted average of Partner's FY19 performance and varies by Partner Type set forth in Table 1 below.
- b. For VMware Partners the Trip Recipients will be selected by VMware independently in its sole discretion. Please check with your VMWare account team for additional information regarding Trip Recipient selection.
- c. Only the top forty-seven (47) performing Partners with highest revenue by Partner Type and allocated by Partner Tier and country in Dell Technologies and VMware's sole discretion, who have met the minimum Revenue Growth thresholds, will be eligible to be awarded a Trip as follows:
 - 1. Thirty-five (35) Solution Providers/Distributors,
 - 2. Seven (7) Global Alliances, and
 - 3. Three (3) OEM Partners
 - 4. Two (2) VMWare Partners
- d. Trip Recipients may only receive one (1) Trip and Partners may only participate as a Dell Technologies Partner or a VMware Partner not both. Partners who participate in multiple tracks or the Dell Technologies Partner Program or the VMware Partner program will only be eligible to be awarded in one Program and in one (1) track where Partner meets the eligibility requirements. Additionally, if Partner earns more than one Trip in multiple tracks or as a Dell Technologies Partner and as VMware Partner, any additional Trips will be awarded to the Partner with the next highest revenue that meets the criteria herein.

* For Solutions Providers/Distributors, there will be Thirty-five (35) awarded Partners and Distributors total: North America (10); Latin America (4); EMEA (8); APJ (6); GC (4) and Distributors (3). **For Global Alliances, there will be seven (7) 'Partner of the Year' recipients for the following categories: Global Alliances Partner of the Year, Americas Systems Integrator/Strategic Outsourcer Partner of the Year, Americas Cloud Service Provider/Telco Partner of the Year, EMEA Systems Integrator/Strategic Outsourcer Partner of the Year, EMEA Cloud Service Provider/Telco Partner of the Year, APJ Systems Integrator/Strategic, Outsourcer Partner of the Year, APJ Cloud Service Provider/Telco Partner of the Year. A Global Alliances partner may only win once. Decisions will be made on closest point differential by category, if needed, and will be approved at the discretion of an Executive Leadership Governance Panel.

***For OEM, there will be three (3) awarded partners total: Americas (1); EMEA (1); and APJ (1).

****For VMWare there will be (2) awarded Partners total as determined by VMWare. Please check with your VMWare account team for additional information regarding Trip Recipient selection.

- e. Only forty-seven (47) Trips will be awarded and in no event shall the total number of Trips awarded exceed forty-seven (47).
 - f. Travel will be arranged by Dell Marketing L.P. ("Sponsor") through Sponsor's travel coordinator Maritz Travel ("Travel Coordinator") with offices at: 1395 North Highway Dr.; Fenton MO, 63099.
 - g. Except where prohibited, the Trip includes:
 - Airfare,
 - Lodging, (All lodging arrangements are based on double occupancy.)
 - Transfers from and to destination airport,
 - Food costs with the travel group,
 - Entertainment costs with the travel group, and
 - Breakout training sessions
 - h. No monetary award will be given in lieu of the Trip.
 - i. **Product Purchases:** Partner must purchase Dell EMC products and services from Dell Global Commercial Channels segment or an Authorized or Preferred Distributor. Such purchases shall be governed by the terms provided in the Dell Technologies Partner Program Agreement. Dell Technologies reserves the right to exclude certain products sales opportunities from any revenue and growth threshold calculations at any time in its sole discretion.
 - j. **Eligibility of Sales:** Dell Technologies and VMware reserves the right to determine the eligibility of any sales opportunity under this Program in its sole discretion. Only those opportunities that Dell Technologies determines are eligible shall qualify for the Program and all decisions made by Dell Technologies are final. Purchase orders must be received by Dell Technologies and the order, must ship (for Legacy Dell Eligible Products) or be booked (for Legacy EMC Eligible Products) not prior to the start of the Program Period and no later than the last day of the Program Period to qualify for this Program.
 - k. Purchases of refurbished products are excluded from the calculations of minimum revenue and growth thresholds for Partner participation in this Program and are excluded from any calculations available through this Program.
 - l. **Federal End-Users the United States:** In the United States sales of Eligible Products to Federal end-user customers shall not qualify for this Program or any minimum revenue and growth threshold calculations. Any existing Marketing Incentive Fund agreement that Partner may have with the Dell Federal Sales Segment shall remain in place notwithstanding this Agreement. Sales to consumers; distributors or third-party sales agents; any government (including federal, provincial, state or local government) or education end-users; or customers purchasing products or services that will be reimbursed under a federal healthcare program are excluded from any calculations of revenue or incentives under this Program.
6. **Travel Requirements:** Trip Recipients and Guests must be at least twenty-one (21) years of age or older. Recipients of the Trip and their Guests must be able to travel on the dates specified by Sponsor. The Trip Recipient and their Guest must have valid proof of identification to travel, as required by the country of residence of the Trip Recipient and Guest, as well as, the destination country.
- a. To be eligible to travel, all information and details to purchase travel must be given to Sponsor's Travel Coordinator within seven (7) business days after notification. If this information is not provided to the Travel Coordinator by this date, the Partner will forfeit the Trip to the next eligible Partner with the next highest revenue. All country, federal, state and local laws and regulations apply.
 - b. All expenses not specifically mentioned above are not included and are solely the Trip Recipients' and their Guests' responsibility including, but not limited to: round trip transportation between the Trip Recipients' and their Guests' residence and departure and return airport, alcoholic and non-alcoholic beverages and meals outside the Dell planned activities, incidentals, gratuities, incidental and personal expenses, laundry service, merchandise, mini-bar, parking, room service, service charges, souvenirs, telephone calls, cellular telephone surcharges due to usage on the Trip, any unspecified state or local taxes or government surcharges or fees, service charges, facility fees,

security fees, passenger tariffs or duties, and all other expenses incidental to the acceptance, participation in and enjoyment of the Trip.

- c. Travel is subject to the restrictions and conditions set forth in these Official Rules. The Trip must be completed with the group of Trip Recipients and their Guests during the period specified by Sponsor. All Trip related travel arrangements will be administered by Sponsor's Travel Coordinator. Trip is subject to capacity controls, availability, blackout dates and certain other restrictions, all of which are subject to change. Each Trip Recipient and his/her Guest will be required to travel on identical itineraries including same departure date and time and return date and time. Trip Recipients and Guests are responsible for obtaining any necessary travel documents (i.e., valid, government-issued photo identification, appropriate other related documents required for travel). If a Trip Recipient elects to travel or partake in the Trip without a Guest, no additional compensation will be awarded to the Trip Recipient. Air transportation and hotel accommodations must be taken together and cannot be taken separately. No changes will be made to the travel details once any element(s) of the travel arrangements have been booked, except at Sponsor's sole discretion. All airline-issued airline tickets issued in conjunction with the Trip are not eligible for upgrades, frequent flyer miles or any other promotional benefit. Sponsor will not replace any lost or stolen tickets, travel vouchers or certificates or similar items once they are in the Trip Recipient's possession or in the possession of the Trip Recipient's Guest. Travel must be round-trip. Sponsor will determine flight itinerary in its sole discretion. Any unclaimed and/or unused Trip package or element thereof will be forfeited by Trip Recipient and will remain the property of Sponsor. No refund or compensation will be made in the event of the cancellation or delay of any flight. Travel is subject to the terms and conditions set forth in these Official Rules, and those set forth by Sponsor's Travel Coordinator, as detailed in the passenger ticket contract issued by such supplier.
- d. The right to receive a Trip is non-assignable, non-transferable and no award substitution, exchange or cash equivalent will be allowed, except by Sponsor who reserves the right to substitute an award of equal or greater value in case of unavailability of Trip or force majeure.

7. Trip Fulfillment and Releases: Potential recipients will be notified within Seven (7) business days after the end of the Program Period if he/she has been selected to receive a Trip. All potential recipients are required to return to Sponsor an AFFIDAVIT OF ELIGIBILITY and LIABILITY RELEASE (Attached hereto as Exhibit A), Counsel/Designated Executive/Ethics Officer Approval Form (Exhibit B), and their Guests may be required to return to Sponsor a LIABILITY AND PUBLICITY RELEASE FOR TRAVEL COMPANION (Attached hereto as Exhibit C) and any applicable Tax Forms within seven (7) business days of notice of receiving a Trip.

- a. **Permissible Acceptance.** If Partner, Trip Recipient, or Guest are not permitted to participate in this Program under the laws, regulations or employer policy applicable to them, they should not participate. This Program is being offered only to the extent a Partner, Trip Recipient, or Guest is permitted under the laws, regulations and policies applicable to them. The approximate value of this Program has been provided to Partner in writing and Partner is aware that it is under no obligation to confer any business advantage on Dell as a participant in this Program. It is the obligation of each Trip Recipient and Guest to obtain authorization from their employer's legal or ethics department that they are permitted to participate in the Program and, if applicable, accept the Trip.

Potential Trip Recipients or Guests who are Public Officials, currently holding a political office, or are otherwise employed by or affiliated with State Owned Enterprises (SOE)s' and/or a Government/Publicly funded/owned or controlled Partner, or a Politically Exposed Person (PEP). (*Generally, officials, either current or former, affiliated with foreign political parties; individuals associated with corporations owned or operated by a foreign government; or their family members or others with whom they are personally or professionally close*) are not eligible to participate in the Program or receive a Trip. By participating in this Program Trip Recipients and Guests disclose their affiliation with and provide consent to allow Dell Technologies or Dell Technologies' authorized vendor to verify Trip Recipient or Guest's employment or affiliation with any of the aforementioned entities. Any data collected by Dell Technologies will be subject to the Dell Technologies Privacy Policy set forth in Section 13 below.

- b. **Compliance with the law.** Partner represents and warrants that it understands and agrees to comply with the U.S. Foreign Corrupt Practices Act, the UK Bribery Act, and any other anti-bribery laws in countries in which this Program is being offered (collectively, the "Anticorruption Laws"). Partner represents that this Program and the Trip are not being given by Dell, and will not be used by Partner, Trip Recipient or Guest, directly or indirectly, as an attempt to influence any act or decision of Partner, Trip Recipient or Guest in connection with obtaining, retaining, or directing business or securing any improper business advantage on behalf of Dell.

- 8. Release:** By entering, Partners agree to release and hold harmless the Sponsor, Dell Inc., VMware Inc. and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and Trip suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Program or receipt or use or misuse of the Trip.
- 9. General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Program, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Program, as determined by Sponsor in its sole discretion. If terminated, Sponsor may, in its sole discretion, determine the recipients from among all non-suspect, eligible Entries received up to time of the Program end date outlined above. Sponsor, in its sole discretion, reserves the right to disqualify any individual it finds to be tampering with the Submission process or the operation of the Program or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner and void all associated Entries. Any attempt by any person to deliberately undermine the legitimate operation of the Program may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages and other remedies (including attorneys' fees) from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- 10. Taxes:** All applicable taxes (including, but not limited to, Value Added Tax and Withholding Taxes) on incentives or awards are the sole responsibility of the Trip Recipients and their Guests. In certain circumstances, Dell Technologies may elect to pay applicable taxes on the amount of Incentives. Partner may be required to provide relevant tax information to Dell Technologies for tax reporting purposes. Failure to provide requested tax information, where applicable, to Dell Technologies within thirty (7) days after Dell Technologies' request may result in forfeiture by Partner of any incentives or awards.
- 11. Limitations of Liability:** Released Parties shall not be responsible or liable for sales calculations that are late, forged, destroyed, lost, misplaced, stolen, misdirected, tampered with, incomplete, deleted, damaged, garbled, or otherwise not in compliance with these Rules, and all such sales numbers will be disqualified. Released Parties are also not responsible for: (1) any incorrect or inaccurate information, whether caused by Trip Recipient, printing, typographical or other errors or by any of the equipment or programming associated with or utilized in the Program; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the Submission process or the Program; (4) printing, typographical, technical, computer, network or human error which may occur in the administration of the Program, the uploading, the processing or judging of Entries, the announcement of the Trips or in any Program-related materials; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Trip Recipient or Guest's participation in the Program or receipt or use or misuse of any Trip (including any travel/activity related thereto). Released Parties are not responsible for misdirected or undeliverable Entries or for any technical problems, malfunctions of computer systems, servers, providers, hardware/software, lost or unavailable network connections or failed, incomplete, garbled or delayed computer transmission or any combination thereof. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants' rights and obligations, or the rights and obligations of the Sponsor in connection with the Program, shall be governed by, and construed in accordance with, the laws of the State of Texas,

without giving effect to any choice of law or conflict of law rules (whether of the State of Texas or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Texas.
